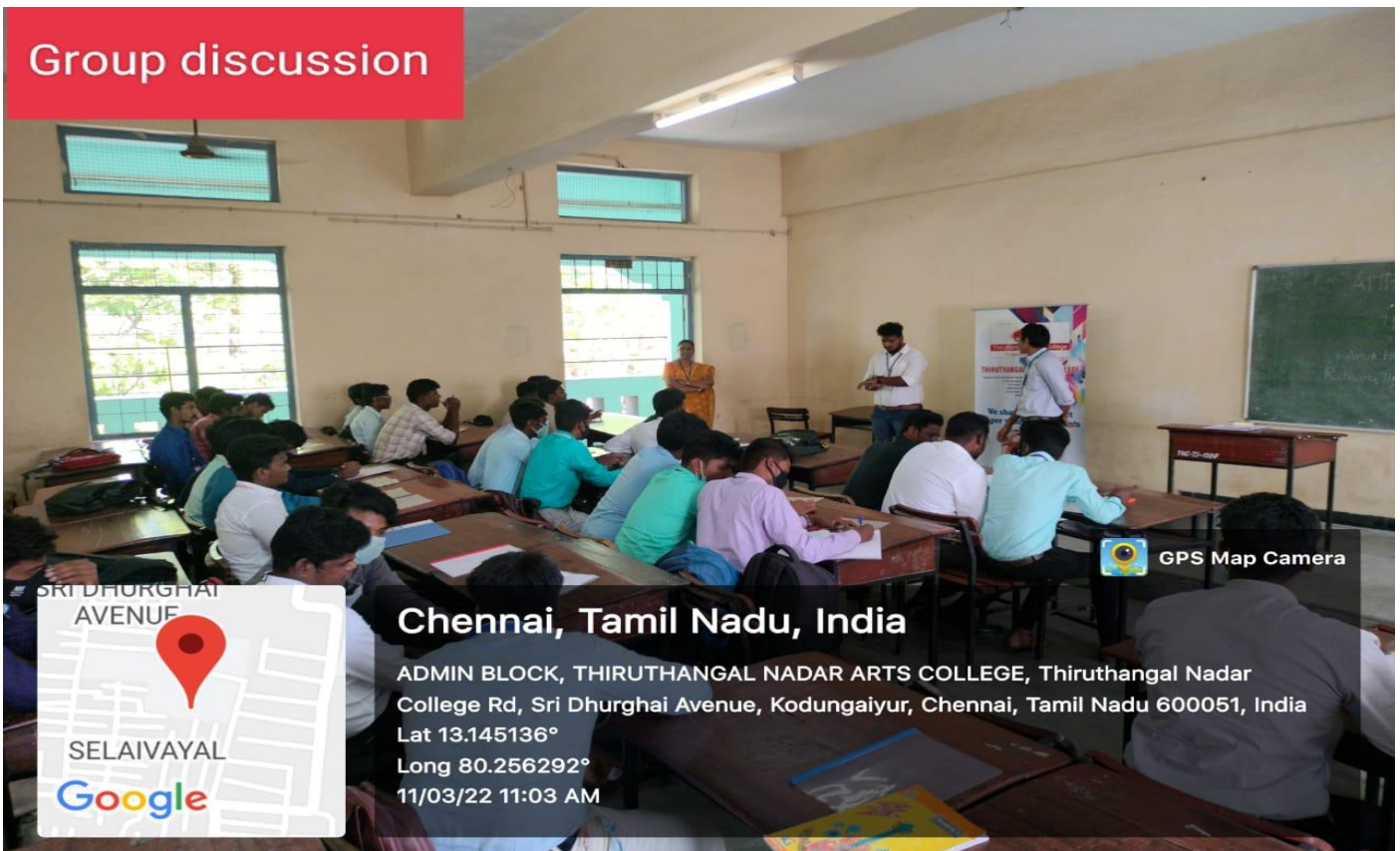

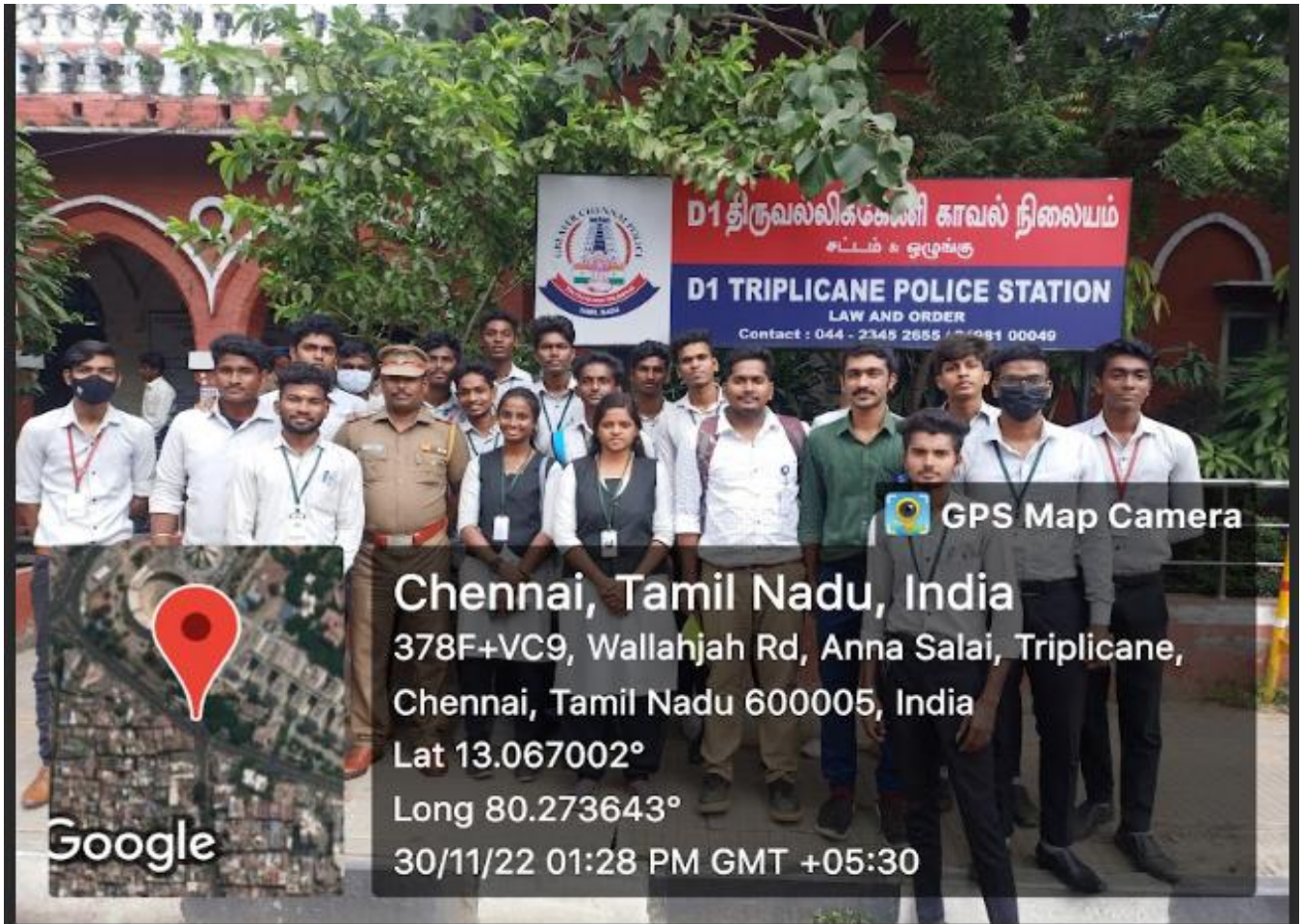

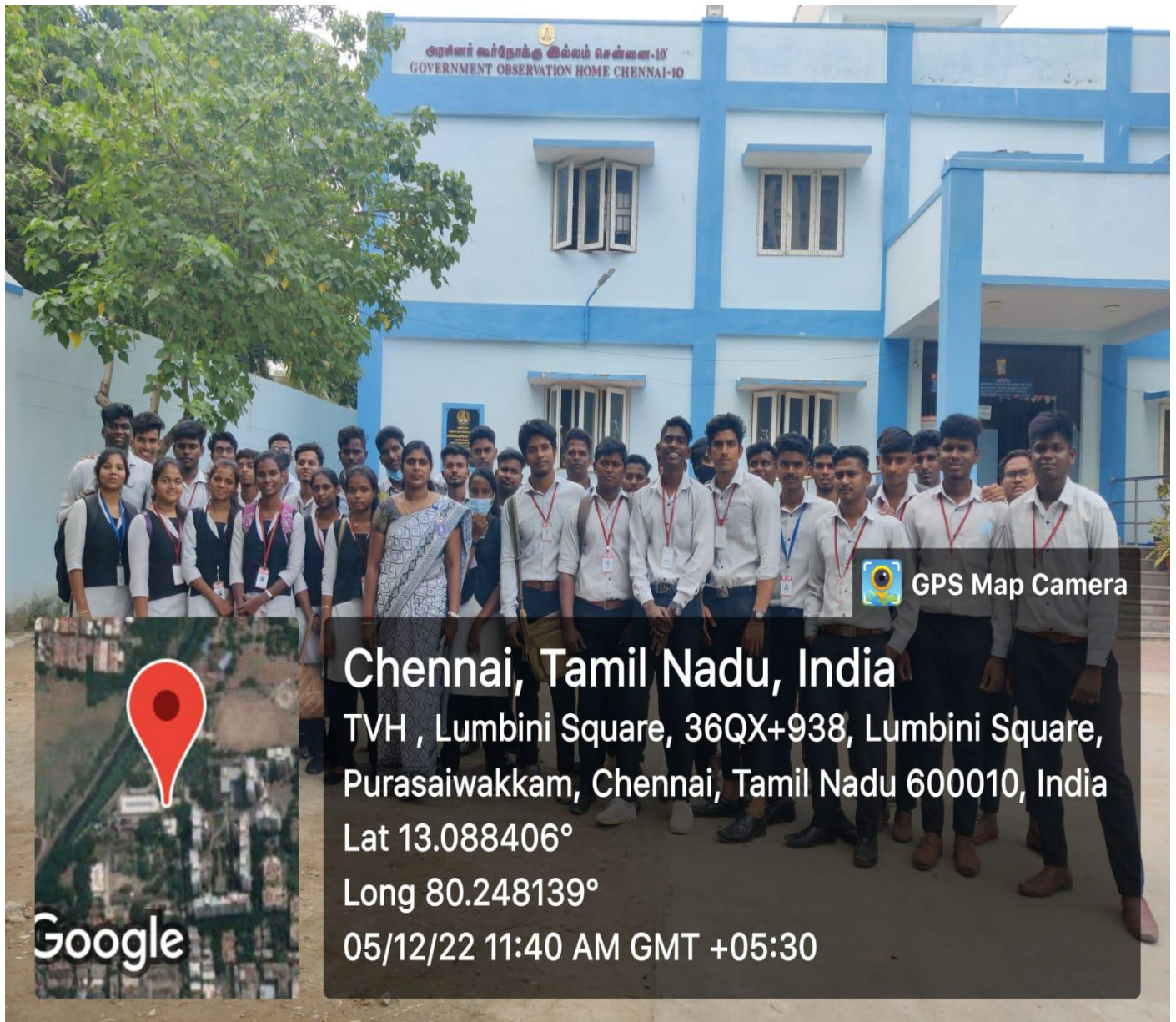


### VISIT TO JUVENILE HOME

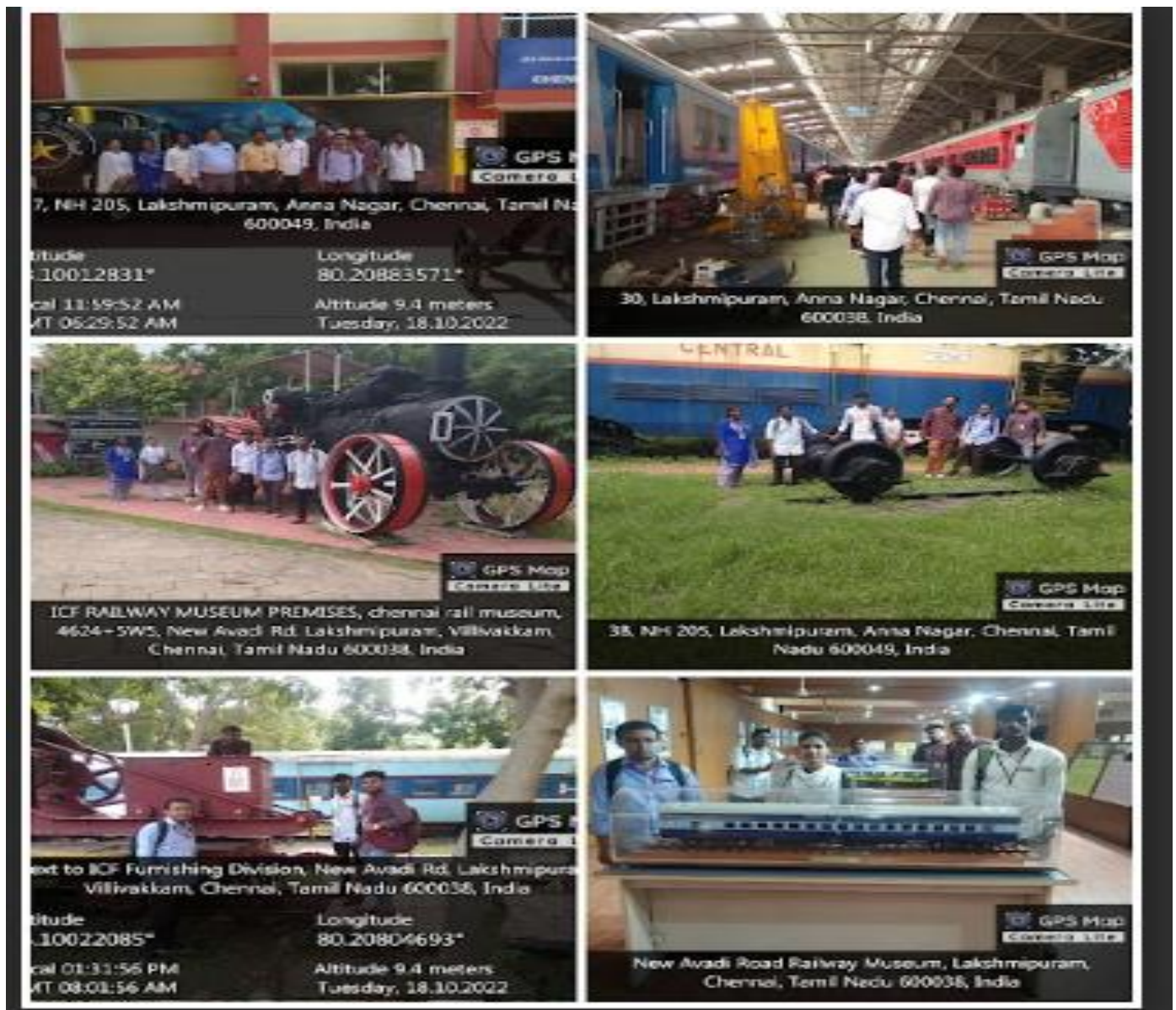


**INDUSTRIAL VISIT TO ICF & CHENNAI RAIL MUSEUM**

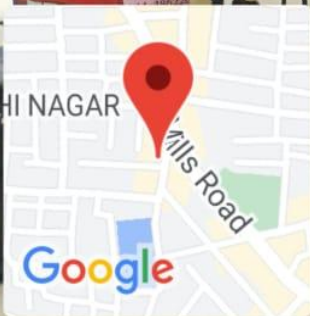


### Industrial visit to Dream zone School of Creative Studies & Computer Applications
